

Futures Trade 2 Free 1 Campaign

Terms & Conditions

For the purpose of this terms and conditions for the Trade 2 Free 1 Campaign (“Campaign”), “Maybank” collectively refers to Malayan Banking Berhad (Company No.: 3813-K) and Maybank Investment Bank Berhad (Company No.: 15938-H).

1. Campaign Period

This Campaign will commence from 22 November 2018 until 31 January 2019 (both dates inclusive, “Campaign Period”).

2. Eligibility

a. This Campaign is open to:-

- i. all existing retail clients of Maybank who own a Futures trading account(s) with Maybank to trade Futures Mini on FTSE Bursa Malaysia Mid 70 Index (“FM70 Futures Trade”) during the Campaign Period; and
- ii. all new retail clients of Maybank who open a Futures trading account with Maybank to trade FM70 Futures Trade during the Campaign Period,

(collectively, “Eligible Clients”).

b. Corporate and institutional clients of Maybank shall not be eligible to participate in the Campaign.

3. Campaign Mechanics

- a. Eligible Clients will be registered for the Campaign automatically when they trade online and/or call-in to trade.
- b. All trades of FM70 Futures Trade will be charged an initial brokerage fee of RM3 per side per lot.
- c. Each Eligible Clients who trades two (2) trades of Futures on FTSE Bursa Malaysia Kuala Lumpur Composite Index (“KLCI Futures Trade”) during the Campaign Period will be entitled for one (1) free/zero trade of FM70 Futures Trade (“Brokerage Rebates”).
- d. The Brokerage Rebates will be credited into the Eligible Client’s futures trading account on the first Friday of the following month (for example, Brokerage Rebates for the month of November 2018 will be credited into the Eligible Client’s Futures trading account on 7 December 2018 being the first Friday of the following month).
- e. Only trades of KLCI Futures Trade will be taken into consideration in calculating the Brokerage Rebates.
- f. All Brokerage Rebates must be utilised/claimed within the Campaign Period failing which such rebates will be forfeited.

4. General Terms and Conditions

- a. Maybank reserves the sole and absolute right upon giving twenty one (21) days' prior notice to alter, shorten, cancel, suspend or terminate this Campaign or any part thereof, the notice of which shall be posted through Maybank2u website at www.maybank2u.com or through any other channel or channels that Maybank may deem appropriate.
- b. For the avoidance of doubt, the alteration, shortening or suspension of the Campaign Period or the suspension or termination of this Campaign by Maybank shall not give rise to any claim or compensation by you or any other persons whatsoever against Maybank for any losses or damages suffered or incurred as a direct or indirect result of the alteration, shortening, cancellation, suspension or termination.
- c. Maybank shall not be liable for any losses, damages or cost incurred or suffered by any clients as a result of your participation in this Campaign. Furthermore, Maybank shall not be liable for any default of its obligation under this Campaign due to any force majeure event which includes but not limited to the act of God, war, riot, lockout, industrial action, fire, flood, drought, storm or any event beyond the reasonable control of Maybank.
- d. The terms and conditions of this Campaign shall be governed by the laws of Malaysia and subject to the exclusive jurisdiction of the courts of Malaysia.
